



## VIDAPAY Smart TV Giveaway Contest 2022

### OFFICIAL RULES

**1. NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE OFFICIAL RULES. MANY WILL ENTER; ONE WILL WIN THE GRAND PRIZE.**

**2. Entry Period.** The VIDAPAY Smart TV Giveaway Contest (the “Contest”) begins at 12:00:01 A.M. EST on April 22, 2022 and ends at 11:59:59 P.M. EST on May 31, 2022 (“Contest Period”). Entry dates are subject to change. Entries that are submitted before or after the Contest Period will be disqualified.

**3. Eligibility.** The Contest is open to legal residents of the fifty (50) United States, the District of Columbia and Puerto Rico (“Contest Area”) who are eighteen (18) years of age or older as of the date of entry and who are current registered owners of an authorized T-CETRA dealer in good standing that sells Google Play products. Only owners of T-CETRA authorized dealers in good standing are eligible to participate in the Contest. The designated owner of a T-CETRA authorized dealer must be an owner of the T-CETRA authorized dealer at such time that their entry is submitted and at such time as the authorized dealer is selected to win a prize. Internet access and access to the VIDAPAY™ portal is required in order to enter this Contest. Void where prohibited. The Contest and any web sites, web pages and advertisements relating thereto are intended for viewing only within the Contest Area. Entries received from persons residing outside of the Contest Area or where restricted will be disqualified. Employees, officers, directors, and members of the Sponsor (as defined below), and their immediate family members (spouse and parents, children and siblings, and their respective spouses, regardless of where they live) and individuals living in the same households of each of these individuals, whether related or not, of the above are not eligible to enter or win. The Contest is subject to all applicable federal, state, territorial and local laws.

**4. How to Enter.** During the Contest Period, authorized dealers will receive one or more entries into the Contest upon completion of each “Eligible Action” listed below (each an “Eligible Entry” and collectively, “Eligible Entries”), in accordance with the following:

**5. Prizes, Number and Selection of Winners.** There will be thirteen (13) total winners selected in drawings based on Eligible Entries received up until the end of the Contest Period, as follows:

- **One (1) authorized dealer will be selected to win the Grand Prize of a TCL, 4K UHD HDR high resolution 55” flat screen Smart TV; (valued at \$359)**



- **Twelve (12) authorized dealers will be selected to win a prize of \$50 VIDAPAY Credit**

**Authorized dealers are limited to one (1) prize during the Contest Period**, Winners will be selected on June 1, 2022. If the authorized dealer’s entry is selected to win a prize and if such authorized dealer has more than one eligible owner, the authorized dealer will be required to designate one individual owner who shall be deemed to be the winner of the prize. Entries will be submitted through the VIDAPAY™ portal upon completion of each Eligible Action. The number of Eligible Entries will be tracked from VIDAPAY transactions, and determined through the VIDAPAY™ portal. Not all products and services will be available to every dealer.

**6. Odds.** Approximately one (1) in five (5) authorized dealers will win. The odds of being selected will depend on the number of participants, and the number of Eligible Entries received during the Contest Period as a result of the number of Eligible Actions completed by each authorized dealer. A registered dealer is only permitted to win one prize.

**7. Prizes.** Cash prizes will be awarded during the Contest in accordance with the following:

**8. Prize Restrictions and Conditions.** A potential winner who satisfies all of the Contest requirements will be designated an official winner (“winner”). Non-compliance with the Official Rules, Sponsor’ inability to contact a potential winner, or if such prize notification is rejected or returned as undeliverable will result in the potential winner’s disqualification and, at Sponsor’s sole discretion, the prize may be awarded to an alternate winner selected in the same manner as described hereinabove. The winner is responsible for any and all federal, state, territorial and/or local taxes, and the reporting consequences thereof, including but not limited to income tax, surcharges and any other taxes incurred as a result of winning or accepting the prize, except as Sponsor may otherwise expressly agree in writing. **9. Conditions of Participation.** By entering, entrants agree to be bound by these Official Rules including all eligibility requirements and the decisions of the Sponsor, which are final and binding. By accepting a prize, the winner consents to the use of his/her/its name for advertising, publicity, and promotional purposes by the Sponsor, or a party designated by Sponsor, in any and all media now or hereafter devised, including but not limited to, any online announcements, worldwide in perpetuity, without additional compensation, notification, or permission, except where prohibited by law. Entrants release and hold harmless Sponsor from any claims, actions, injury, loss, or damage of any kind, including but not limited to, personal injury or death, resulting, directly or indirectly, in whole or in part, from participating in this Contest or from the acceptance, possession, or use or misuse of the prize. **10. Announcement of Winners.** The winners will be posted on the VIDAPAY™ portal, social media, and/or communicated via email or text messages as they are selected or shortly thereafter. Winners may be videotaped or recorded upon receiving notice that they have won a prize.

**11. General.** By entering, entrant understands that entrant is providing his/her/its information to the Sponsor. The information provided will be used for the purpose of the Contest and to notify the potential winner. Sponsor are not responsible for entries that are lost, misdirected, or failed to enter into the VIDAPAY™ system, or are processed, reported, or transmitted late or incorrectly; or for any other errors or problems of any kind, whether typographical, printing, mechanical, human, electronic, or otherwise, relating to or in connection with the Contest, including, without limitation, any error or problem that may occur in connection with the administration of the Contest, the processing of entries, the announcement of the prize, or in any Contest-related materials. Entry materials that have been tampered with or altered are void. The Sponsor reserve the right, in its sole discretion, to cancel or suspend part or all of this Contest at any time without notice and for any reason, including if in Sponsor' opinion, there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of the Contest, or if virus, bugs, non-authorized human intervention or other causes corrupt or impair the administration, security, fairness, or integrity and proper play of the Contest. Disputes.** Except where prohibited, all issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the eligible participant and Sponsor in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the State of Ohio, without giving effect to any choice of law or conflict of law rules (whether of the State of Ohio, or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Ohio.
